- \* NO RESERVATIONS - FIRST COME FIRST SERVED - REGISTER AT NORTH GATE.
- \* CAMPGROUNDS OPEN TO PUBLIC FRIDAY AUGUST 11th.
- \* CLUB RESERVES RIGHT TO DENY CAMPING PRIVILEGES  
(the huge majority of our past campers are great, but there are a few we don't want back).
- \* POTABLE WATER, SHOWERS, RESTROOMS, DAILY GARBAGE PICKUP AND PORTA  
JOHNS - NO ELECTRICAL HOOKUPS.
- \* GARBAGE PICKUP 10:00 DAILY - PLEASE KEEP AND LEAVE SITE CLEAN.
- \* MUST BE MINIMUM OF 18 YEARS OLD TO REGISTER A CAMPSITE.
- \* AGES 17 AND UNDER MUST HAVE PARENT OR GUARDIAN.
- \* \$36 FLAT RATE FEE (see exhibitors and vendors information) INCLUDES 2 ADULTS.  
Additional adults (18 and older) \$5/person.
- \* \$20 WEEKEND SHOWGROUNDS PASS REQUIRED FOR EACH PERSON.
- \* ALL CAMPERS MUST REGISTER PRIOR TO SETTING UP.
- \* ONE VEHICLE PER SITE. ADDITIONAL VEHICLES CAN BE PARKED IN SPECTATOR  
LOT.
- \* NON CAMPING TRAILERS MUST BE PARKED IN TRAILER PARKING AREA.
- \* TRACTORS NOT ALLOWED IN WEST SIDE CAMPING AREA EXCEPT  
FOR BRIEF TIME FOR PULLING EQUIPMENT CHANGES OR REPAIRS.
- \* CAR PASSES (if issued) MUST BE VISIBLE THROUGH WINDSHIELD,
- \* WRISTBAND WILL BE ISSUED AT REGISTRATION AND MUST BE WORN FOR  
DURATION OF SHOW.

- \* **CAMPING STICKER MUST BE DISPLAYED VISIBLE TO STAFF.**
- \* **PERSON REGISTERING RESPONSIBLE FOR ALL AT SITE.**
- \* **GENERATORS - PLEASE BE CONSIDERATE OF YOUR NEIGHBORS. GENERATORS MUST BE SHUT OFF DURING QUIET TIME. (for generators required for medical purposes please discuss with one of the registration or camping staff).**
- \* **QUIET TIME - 11:00 PM UNTIL 7:00 AM.**
- \* **PETS MUST BE ON LEASH, ARE NOT ALLOWED OUT OF CAMP AREA (official service animals excluded), MUST BE CLEANED UP AFTER AND CONTROLLED (including barking).**
- \* **NO CAMPING IN SPECTATOR PARKING LOT.**
- \* **PERSONAL ONSITE TRANSPORTATION AND PEOPLE MOVERS.**  
- SEE *PERSONAL TRANSPORTATION*
- \* **HAVE A GREAT TIME AND ENJOY YOURSELF AND THE SHOW, BUT PLEASE BE SAFE AND RESPECTFUL OF OTHERS.**

### **MEMBERS ONLY**

- \* **CAMPING UNITS MAY BE SET UP ANYTIME AFTER GROUNDS OPENING IN THE SPRING IF YOU HAVE A PERMANENT SITE. PERMANENT SITE HOLDERS MUST ALSO REGISTER AT SHOWTIME.**
- \* **PERMANENT SITES TO BE MAINTAINED BY ASSIGNEES AND VACATED BY OCT. 31<sup>st</sup> YEARLY.**
- \* **MEMBERS WITHOUT A PERMANENT SITE CAN SELECT AND SETUP THEIR CAMP SITE THE DAY OF THE AUGUST CLUB MEETING WITH ASSISTANCE FROM CAMPING STAFF.**
- \* **ALL OTHER RULES ABOVE (except fees and permanent site parking) APPLY TO MEMBERS ALSO.**
- \* **FAILURE TO ABIDE BY RULES WILL RESULT IN ONE YEAR PROBATION FOR FIRST VIOLATION AND LOSS OF CAMPING PRIVILEGES FOR 2<sup>nd</sup> YEAR VIOLATION.**
